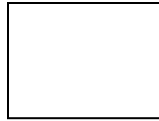

**San Bernardino County
Off Highway Vehicle
Ordinance**

Operating an off-highway motor vehicle on private or public property without written permission from the owner of that property is not permitted.
(28.0403 SBCC)

OHV staging on private property of less than 2.5 acres is not permitted. Staging for longer than 6 days in a 30-day period is not permitted. This is consistent with the provisions of this Chapter.
(28.0404 SBCC)

No off-highway motor vehicle shall exceed the noise standards established in California Vehicle Code applicable to off-highway motor vehicles.
(28.0405 SBCC)

It is unlawful to operate an OHV or participate in staging activity in a manner that disturbs the peace or quiet of any neighborhood or person by noise, dust, smoke, or fumes.
(28.0406 SBCC)

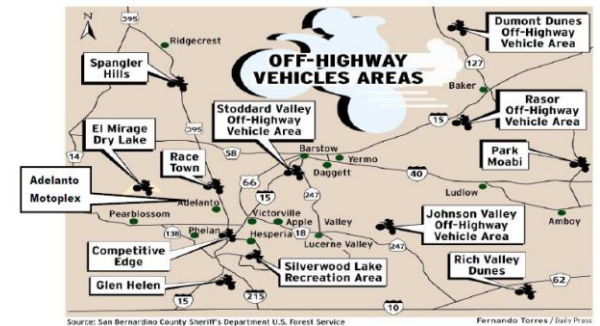

Where Can I Ride?

You can lawfully operate an off-highway vehicle on your own property or on the property of another while in possession of written permission from that property owner, if you do not disturb the peace and quiet of any neighborhood or person by noise, dust, smoke, or fumes.
