- CONDITIONAL USE PERMIT (CUP) FOR THE CONSTRUCTION OF A SEWER PACKAGE TREATMENT PLANT TO SERVE THE SINGLE FAMILY STRUCTURES WITHIN TENTATIVE TRACT 18255.
