Mitigation measures TCR-1, TCR-2, CR-1, and CR-2 were provided by Yuhaaviatam of San Manuel Nation during AB52 consultation. To insure adequate and compliant management of any buried remains that may be identified during Project development, mitigation measure CR-3 is required as a condition of Project approval. Implementation of Mitigation Measure GEO-1 would ensure that impacts due to seismic activity are reduced to the extent feasible. Paleontological resources may occur anywhere and therefore, mitigation measure GEO-2 is required to address potential impacts to paleontological resources.
