The County of San Bernardino is continuing to hold Planning Commission meetings to conduct essential County business. Comments received after an agenda item will be made part of the record if received prior to the end of the meeting.

The agenda items are normally heard in their scheduled order; however, the Commission may choose to hear the items out of the scheduled order.
