PROPOSAL: A Conditional Use Permit for the development of a 165,324 square foot industrial warehouse distribution facility and lot merger of five parcels into one. The building will include 9,000 square feet of office space. The project is located on the south side of San Bernardino Avenue between Commerce Drive and Mulberry Avenue on 10.13 acres.
