SUBJECT: **COMMUNITY PLANS CONTINUUM (CPC) UPDATE**

On November 3, 2016, staff held the Planning Commission Workshop to introduce proposed revisions to the Countywide Land Use Map resulting from public input at the Detailed Community Plan Workshops in twelve communities. This presentation will be an update on the CPC process.

We completed all 66 Community Plan Workshops in over 50 communities. We have completed the draft Detailed Community Plans and they are out for public review. The Press Release is attached.
